**Request for Proposals: Medical Specialty Services**

**1. General**

The Department of Health and Social Affairs (DHSA) of the FSM National Government (hereinafter referred to as “government”) hereby solicits proposals from interested non-profit organizations, individuals, or medical groups (hereinafter referred to as “applicants”) to provide specialty medical services in ophthalmology & optometry, ENT, dentistry, cardiology, orthopedics, and urology in any or all the FSM States of Chuuk, Pohnpei, Yap, and Kosrae. Preference will be given to applicant who demonstrates ability to provide health care to patients in all four FSM States.

**2. Eligibility**

Group or individuals who are in good standing or who are licensed to practice medicine in the FSM.

**3. Format of Bid Submission**

Applicant may submit a proposal in any generally accepted style and format as long as it provides the necessary information as follows:

- A. Name and Address of Agency

- E. Copies of current medical license, business license, or non-profit organization certificate.
