This update and reminder is for FSM citizens residing in the United States and its territories.

The Embassy is closely monitoring the incoming Administration's policies on immigration and other issues of interest to our citizens.

We want to assure you that the FSM Embassy in Washington, DC, in close collaboration with its partners, is closely tracking the new policies as they are unfolding.

The situation is very fluid at the moment and we are working to assess the impacts these changes may have on FSM citizens, if any. We will issue future updates if and when needed.

As a general matter and regardless of any changes in policy under the new Administration, we encourage all FSM citizens do the following:

- Please keep in your close and immediate possession the relevant documents that are used as evidence of your lawful status while residing in the United States. These include your valid, unexpired FSM passport and a copy of your I-94. (The link for the U.S. Dept. of Homeland Security I-94 info page is provided in the box to the right.)
- Should you encounter any situation that may warrant immediate and urgent attention, please contact the nearest FSM office in the U.S., including the FSM Embassy in D.C. and the FSM Consulate Generals in Guam, Honolulu, and Portland. See the box at the right for contact details.
